1. Website Visitors

Like most website operators, Vedic township collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. 6. Vedic township uses Google AdWords for remarketing

Vedic township uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site. 7. Protection of Certain Personally-Identifying Information

Vedic township discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Vedic township's behalf or to provide services available at Vedic township's website, and (ii) that have agreed not to disclose it to others.
